### On a weakly hyperbolic equation with a term of order $zero^{(*)}$

**RÉSUMÉ.** — Nous étudions une équation faiblement hyperbolique du second ordre, en supposant que les coefficients de la partie principale sont fonctions analytiques qui ne dépendent que du temps. Nous démontrons que, en ajoutant un terme d'ordre zéro c(t, x)u avec  $c \in C(\mathbb{R}^{n+1})$ , le problème de Cauchy reste bien posé dans  $C^{\infty}$ .

**ABSTRACT.** — We study a weakly hyperbolic equation of second order, supposing that the coefficients of the principal part are analytic and depend only on time. We prove that if we add a term of order zero c(t,x)u, with  $c \in C(\mathbb{R}^{n+1})$ , the Cauchy problem remains well-posed in  $C^{\infty}$ .

#### 0. Introduction

In the literature many authors study the Cauchy problem in  $C^{\infty}$  for a weakly hyperbolic equation of second order

$$u_{tt} - \sum_{ij} a_{ij}(t) u_{x_i x_j} = 0, \qquad (0.1)$$

with

$$a(t,\xi) = \sum a_{ij}(t)\xi_i\xi_j \ge 0 \quad (\xi \in \mathbb{R}^n).$$

$$(0.2)$$

In [CJS] it is studied the case of analytic coefficients  $a_{ij}(t)$  in [0, T], showing that the Cauchy problem is well-posed. The same method works

when we add a term of order zero c(t)u to the equation, with the coefficient c(t) in  $L^1(0,T)$ . It follows from the proof of the theorem in [CJS] that the same conclusion holds if  $a_{ij} \in C^1([0,T])$  and satisfy the logarithmic condition.

$$\int_0^T \frac{|a_t'(t,\xi)|}{a(t,\xi)+1} \, \mathrm{d}t \le N \log(1+|\xi|) + C \,, \quad \forall \, \xi \in \mathbb{R}^n \,. \tag{0.3}$$

Oleinik [Ol] studies equations of the type:

$$u_{tt} - \sum_{ij} \left( a_{ij}(t, x) u_{x_i} \right)_{x_j} + c(t, x) u = 0, \qquad (0.4)$$

supposing that  $a_{ij}(t, x)$ , c(t, x) are of  $C^{\infty}$  class in  $[0, T] \times \mathbb{R}^n$ , satisfying (2) and

$$\sum_{ij} a'_{ij,t}(t,x)\xi_i\xi_j + C\sum_{ij} a_{ij}(t,x)\xi_i\xi_j \ge 0$$

$$(0.5)$$

or

$$-\sum_{ij} a'_{ij,t}(t,x)\xi_i\xi_j + (\alpha(T-t))^{-1}\sum_{ij} a_{ij}(t,x)\xi_i\xi_j \ge 0.$$
 (0.5')

Then there is also well-posedness in  $C^{\infty}$ . If  $a_{ij}(t)$  are analytic, Oleinik conditions (5), (5') may fail to hold, for example take  $a(t,\xi) = (\xi_1 - t\xi_2)^2$ .

Kajitani [Ka], in a recent paper, considers the equation

$$Pu = \left[\partial_t^2 - \sum_{ij} a_{ij}(t, x)\partial_{x_i}\partial_{x_j} + \sum_j a_j(t, x)\partial_{x_j}\right]u = 0, \qquad (0.6)$$

with coefficients in  $C^1([0, T]; C^{\infty})$ .

Posing  $\langle \xi \rangle^2 = 1 + \sum_j \xi_j^2$ , he assumes (2) and that there is  $f(t, x, \xi) \in C^{\infty}(\mathbb{R} \times \mathbb{R}^n \times \mathbb{R}^n)$  such that

$$\begin{aligned} \frac{\left|a_{t}'(t,x,\xi)\right|}{a(t,x,\xi) + \left(f(t,x,\xi)\right)^{2}} + \frac{\left|\sum_{j} a_{j}(t,x)\xi_{j}\right|}{\sqrt{a(t,x,\xi) + \left(f(t,x,\xi)\right)^{2}}} &\leq f(t,x,\xi) \,,\\ \Lambda(t,x,\xi) &= \int_{0}^{t} f(s,x,\xi) \,\mathrm{d}s \leq C \left(\log\langle\xi\rangle + 1\right) \,,\\ \left|f_{\left(\beta\right)}^{\left(\alpha\right)}(t,x,\xi)\right| &\leq C_{\alpha,\beta} \left(f(t,x,\xi)\right)^{1+\left|\beta\right|} \langle\xi\rangle^{-\left|\alpha\right|} \,, \quad \forall \; \alpha, \; \forall \; \beta, \; \left|\beta\right| < 1 \,,\\ \exists \; \delta > 0 \quad \text{s.t.} \quad \Lambda_{t}^{2} - a(t,x,\Lambda_{x}) \geq \delta \left|(\Lambda_{t},\Lambda_{x})(t,x,\xi)\right|^{2} \,,\\ (t,x) \in [0,T] \times \mathbb{R}^{n} \,, \; \xi \in \mathbb{R}^{n} \,. \end{aligned}$$

Then he proves that the Cauchy problem for (6) is well-posed in  $C^{\infty}$ . The same result should be true in the presence of a term of order zero.

In this paper we shall study again the hyperbolic equation (4)

$$u_{tt} - \sum_{ij} a_{ij}(t) u_{x_i x_j} + c(t, x) u = 0$$

with analytic coefficients  $a_{ij}(t)$  satisfying (2) and with the coefficient  $c(t,x) \in C([0,T]; C^{\infty})$  depending also on space variables. We prove that there is  $C^{\infty}$  well-posedness. We observe that there exist analytic coefficients  $a_{ij}(t)$  which don't verify Kajitani conditions (see the appendix). We show the  $C^{\infty}$  well-posedness also if  $a(t,\xi) = a(t) \sum \xi_j^2$ , with  $a(t) \in C^1([0,T])$ , satisfying (2) and (3). We don't know if this is still true for a generic quadratic form  $a(t,\xi) = \sum_{ij} a_{ij}(t)\xi_i\xi_j$ .

#### 1. The logarithmic condition

Let  $a_{ij}(t)$  be analytic functions on [0, T], satisfying (0.2).

We have the following results (stated without proof in [CJS]).

LEMMA 1. — The function

$$t \mapsto a'_t(t,\xi)$$

vanishes identically or has at most m roots in [0, T] for every  $\xi \in \mathbb{R}^n$ , where m is an integer independent of  $\xi$ .

Proof. - Lemma 1 is a consequence of the following statement:

"if  $a_1(t), \ldots, a_k(t)$  are real analytic functions on [0, T], there exists an integer m such that every linear combination of  $a_1(t), \ldots, a_k(t)$ , which is different from zero, has at most m roots."

If  $a_1(t), \ldots, a_k(t)$  are linearly dependent we can eliminate some of them obtaining an independent set. So we can suppose that  $a_1(t), \ldots, a_k(t)$  are linearly independent.

It is enough to prove that for every  $t \in [0, T]$  there exists a neighbourhood U ot t and an integer p such that every linear combination of  $a_1, \ldots, a_k$  has at most p zeroes in U. The thesis follows from the compactness of [0, T].

Let us suppose that there exists a number  $t_0 \in [0, T]$  such that for every p there exists a linear combination  $b_p(t) = \alpha_{1,p}a_1 + \cdots + \alpha_{k,p}a_k$  with at least p isolated zeroes in  $|t - t_0| < 1/p$  and let us derive a contradiction.

We can suppose that  $\alpha_{1,p}^2 + \cdots + \alpha_{k,p}^2 = 1 \quad \forall p \text{ and that } \alpha_{1,p} \rightarrow \alpha_{1,0}, \ldots, \alpha_{k,p} \rightarrow \alpha_{k,0} \text{ for } p \rightarrow +\infty \text{ with } \alpha_{1,0}^2 + \cdots + \alpha_{k,0}^2 = 1, \text{ so that } b_p(t) \rightarrow b_0(t) = \sum_{j=0}^k \alpha_{j,0} a_j(t) \text{ uniformly together with all the derivatives.}$ 

We have that  $b_p^{(h)}(t)$  vanishes in a point  $t_{p,h}$ , with  $|t_{p,h} - t_0| < 1/p$  for  $h = 0, \ldots, p-1$ . Hence

$$b_0^{(h)}(t_0) = \lim_{p \to \infty} b_p^{(h)}(t_{p,h}) = 0$$

So  $b_0(t) \equiv 0$ , contradicting the hypothesis that  $a_1(t), \ldots, a_k(t)$  are linearly independent.

LEMMA 2. — There exist positive constants C, N such that (0.3) is verified.

*Proof.*— By lemma 1, after fixing  $\xi$ , there are 2k + 2 points

$$0 = s_0 \le t_0 \le s_1 \le t_1 \le \dots \le s_k \le t_k = T$$

such that  $a(s,\xi)$  is decreasing for  $s_j \leq s \leq t_j$  and increasing for  $t_j \leq s \leq s_{j+1}$ .

We can choose  $k \leq m/2 + 1$ . We have

$$\begin{split} \int_0^T \frac{\left|a_t'(s,\xi)\right|}{a(s,\xi)+1} \, \mathrm{d}s &= \\ &= \sum_{j=0}^k \int_{s_j}^{t_j} \frac{-a_t'(s,\xi)}{a(s,\xi)+1} \, \mathrm{d}s + \sum_{j=0}^{k-1} \int_{t_j}^{s_{j+1}} \frac{a_t'(s,\xi)}{a(s,\xi)+1} \, \mathrm{d}s = \\ &= \sum_{j=0}^k \log \frac{a(s_j,\xi)+1}{a(t_j,\xi)+1} + \sum_{j=0}^{k-1} \log \frac{a(s_{j+1},\xi)+1}{a(t_j,\xi)+1} \leq \\ &\leq (2k+1) \log(C_0\xi^2+1) \leq \\ &\leq 2(m+3) \log(|\xi|+1) + (m+3) \log(C_0+1) \,, \end{split}$$

where  $C_0 = \sup \{ a(t,\xi) : |\xi| = 1, \ 0 \le t \le T \}.$

#### 2. Existence theorem

THEOREM .— We consider the equation

$$u_{tt} - \sum_{ij} a_{ij}(t) u_{x_i x_j} + c(t, x) u = 0, \qquad (2.1)$$

with  $a_{ij}(t)$  real analytic functions on [0, T], fulfilling (0.2). Let c(t, x) be a function in  $C([0, T]; C^{\infty}(\mathbb{R}^n))$ .

Then the Chauchy problem for equation (1) is well-posed.

*Proof.*— By the finite speed of propagation we can suppose  $c(t, x) \in C([0, T]; C_0^{\infty}(\mathbb{R}^n))$ . Let us define the energy

$$E(t,\xi) = \left( |v'|^2 + (a(t,\xi)+1)|v|^2 \right) k(t,\xi) ,$$

where  $v = \mathcal{F}_x u$ ,

$$k(t,\xi) = \exp\left(-\int_0^t \frac{|a_t'(s,\xi)|}{a(s,\xi)+1} \,\mathrm{d}s\right) \left(1+\xi^2\right)^{\sigma}$$

and  $\sigma$  is a real number. Integrating we have:

$$\begin{split} \mathcal{E}(t) &= \int E(t,\xi) \, \mathrm{d}\xi = \int \left[ |v'|^2 + \left( a(t,\xi) + 1 \right) |v|^2 \right] k(t,\xi) \, \mathrm{d}\xi \,, \\ \mathcal{E}(t) &\leq C \int \left[ \left( 1 + \xi^2 \right)^{\sigma} |v'|^2 + \left( 1 + \xi^2 \right)^{\sigma+1} |v|^2 \right] \, \mathrm{d}\xi \,, \\ \mathcal{E}(t) &\geq \frac{1}{C} \int \left[ \left( 1 + \xi^2 \right)^{\sigma-N/2} |v'|^2 + \left( 1 + \xi^2 \right)^{\sigma-N/2} |v|^2 \right] \, \mathrm{d}\xi \,. \\ E'_t(t,\xi) &= \left( 2 \, \Re v'' \overline{v'} + a'_t(t,\xi) |v|^2 + a(t,\xi) \, 2 \, \Re v \overline{v'} + \right. \\ &+ 2 \, \Re v \overline{v'} - \frac{\left| a'_t(t,\xi) \right|}{a(t,\xi) + 1} \left| v' \right|^2 - \left| a'_t(t,\xi) \right| \left| v \right|^2 \right) k(t,\xi) \,. \end{split}$$

To estimate the integral of the right hand side we need the following result.

LEMMA 3.— The function  $k(t,\xi)$ , continuous in  $\xi \in \mathbb{R}^n$ , is a temperate weight function [Hör], that is

$$k(t,\xi+\eta) \le k(t,\xi)C(1+|\eta|)^N, \quad \forall \xi, \eta, \forall t$$
(2.2)

where C, N are positive constants, which don't depend on t.

Proof of the lemma. — It is enough to show that

$$k_1(t,\xi) = \exp\left(\int_0^t \frac{|a_t'(s,\xi)|}{a(s,\xi)+1} \,\mathrm{d}s\right)$$

is a temperate weight function, since

$$k(t,\xi) = k_1(t,\xi)^{-1} (1+\xi^2)^{\sigma}$$
,

where  $(1 + \xi^2)^{\sigma}$  is a temperate weight function, and the inverse and the product of temperate weight functions have the same property. Now we observe that taking k = [m/2] + 1 and

$$0 = s_0 \le t_0 \le s_1 \le t_1 \le \dots \le s_k \le t_k = T,$$
 (2.3)

we have

$$\sum_{j=0}^{k} \log \frac{a(s_j,\xi)+1}{a(t_j,\xi)+1} + \sum_{j=0}^{k-1} \log \frac{a(s_{j+1},\xi)+1}{a(t_j,\xi)+1} \le \exp\left(\int_0^t \frac{|a_t'(s,\xi)|}{a(s,\xi)+1} \, \mathrm{d}s\right)$$

and the equality holds for suitable values of  $s_j$ ,  $t_j$ . Hence

$$k_{1}(t,\xi) = \sup\left\{\prod_{j=0}^{k} \frac{a(s_{j},\xi)+1}{a(t_{j},\xi)+1} \cdot \prod_{j=0}^{k-1} \frac{a(s_{j+1},\xi)+1}{a(t_{j},\xi)+1} : s_{j}, t_{j} \text{ satisfy } (3)\right\}$$
$$= \sup k_{\{s_{j}\},\{t_{j}\}}(t,\xi).$$

It remains to show that  $k_{\{s_j\},\{t_j\}}(t,\xi)$  is a temperate weight function, with constants C, N which don't depend on  $\{s_j\}, \{t_j\}$ . This follows from the fact that  $a(s,\xi)+1$  is a temperate function with constants C, N independent of s.

$$\begin{aligned} a(s, \xi + \eta) + 1 &\leq 2a(s, \xi) + 2a(s, \eta) + 1 \\ &\leq (a(s, \xi) + 1)2(a(s, \eta) + 1) \\ &\leq (a(s, \xi) + 1)C(1 + |\eta|)^2, \\ &- 530 - \end{aligned}$$

On a weakly hyperbolic equation with a term of order zero

$$C = 2 \max\left(1, \sup_{s, |\xi|=1} a(s, \xi)\right) \,.$$

Since k is a temperate weight function, we have

$$\begin{split} \int |\widehat{cu}|^{2} k(t,\xi) \, \mathrm{d}\xi &= \\ &= \int k(t,\xi) \left| \frac{1}{(2\pi)^{n}} \int \widehat{c}(\xi - \eta) \widehat{u}(\eta) \, \mathrm{d}\eta \right|^{2} \mathrm{d}\xi \leq \\ &\leq \int k(t,\xi) \frac{1}{(2\pi)^{n}} \int |\widehat{c}(\xi - \eta)| \left| \widehat{u}(\eta) \right|^{2} \mathrm{d}\eta \, \mathrm{d}\xi \frac{1}{(2\pi)^{n}} \int |\widehat{c}(\eta_{1})| \, \mathrm{d}\eta_{1} \\ &\leq \frac{1}{(2\pi)^{n}} \iint k(t,\eta) |\widehat{u}(\eta)|^{2} |\widehat{c}(\xi - \eta)| C(1 + |\xi - \eta|)^{N} \, \mathrm{d}\eta \, \mathrm{d}\xi \, |||c||| \\ &\leq \int k(t,\eta) |\widehat{u}(\eta)|^{2} \, \mathrm{d}\eta \, \frac{C}{(2\pi)^{n}} \int |\widehat{c}(\xi)| (1 + |\xi|)^{N} \, \mathrm{d}\xi \, |||c||| \\ &\leq |||c|||^{2} \int k(t,\eta) |\widehat{u}(\eta)|^{2} \, \mathrm{d}\eta \leq |||c|||^{2} \mathcal{E}(t) \, . \end{split}$$

Hence

$$\begin{aligned} \mathcal{E}'(t) &\leq \left(2 + \left\| \left| c(t) \right| \right| \right) \mathcal{E}(t) \\ \mathcal{E}(t) &\leq \mathcal{E}(0) \exp\left( \left(2 + \sup \left\| \left| c(t) \right| \right| \right) t \right) \,. \end{aligned}$$

This inequality remains true if we substitute  $a(t,\xi)$  with  $a(t,\xi) + \epsilon\xi^2$ , with  $\epsilon > 0$ . The corresponding equation, which is strictly hyperbolic, will have a solution of class  $C^{\infty}$ . If the initial data  $u_0, u_1 \in C_0^{\infty}(B(x_0, r_0)), x_0 \in \mathbb{R}^n, r_0 > 0$ , the solution has support in  $B(x_0, r_0 + v_{\epsilon}t)$  at the time t  $(v_{\epsilon}^2 = sup_{t,|\xi|=1}[a(t,\xi) + \epsilon|\xi|^2])$ .

The energy estimates allow to bound the norms in  $H^s$  of the solution  $u^{(\epsilon)}(t,x)$ , uniformly with respect to  $\epsilon > 0$ . There will be a solution of the limit problem. The uniqueness can be proved by duality.

*Remark.* — We don't know if the theorem is true for general  $a_{ij}(t)$  of class  $C^1$  fulfilling (0.2), (0.3). If  $a(t,\xi) = a(t)\xi^2$  the following lemma permits to apply the theorem.

LEMMA 4.— If a(t) is of class  $C^1$  and  $a(t,\xi) = a(t)\xi^2$  satisfies (0.2), (0.3), then

$$k(t,\xi) = \exp\left(\int_0^t \frac{|a'(s)|\xi^2}{a(s)\xi^2 + 1} \,\mathrm{d}s\right)$$

is a temperate weight function.

Proof. — We have to verify that

$$\int_0^t \frac{|a'(s)|(\xi+\eta)^2}{a(s)(\xi+\eta)^2+1} \, \mathrm{d}s \le \int_0^t \frac{|a'(s)|\xi^2}{a(s)\xi^2+1} \, \mathrm{d}s + N\log(1+|\eta|) + C \, .$$

It suffices to show that

$$\begin{split} \int_0^t \frac{|a'(s)| (|\xi| + |\eta|)^2}{a(s) (|\xi| + |\eta|)^2 + 1} \, \mathrm{d}s &- \int_0^t \frac{|a'(s)|\xi^2}{a(s)\xi^2 + 1} \, \mathrm{d}s \le N \log(1 + |\eta|) + C \,, \\ \int_0^t \frac{|a'(s)| (2|\xi| |\eta| + |\eta|^2)}{a(s) (|\xi| + |\eta|)^2 + 1} \, \mathrm{d}s \le N \log(1 + |\eta|) + C \,, \\ \int_0^t \frac{|a'(s)| 2|\xi| |\eta|}{a(s) (|\xi| + |\eta|)^2 + 1} \, \mathrm{d}s \le N \log(1 + |\eta|) + C \,. \end{split}$$

Let's pose  $|\xi| = r|\eta|$ , if  $0 \le r \le 1$ , we have

$$\int_0^t \frac{|a'(s)| r |\eta|^2}{a(s)(1+r)^2 |\eta|^2 + 1} \, \mathrm{d}s \le \int_0^t \frac{|a'(s)| |\eta|^2}{a(s)|\eta|^2 + 1} \, \mathrm{d}s \le N \log(1+|\eta|) + C.$$

If r > 1, we have

$$\int_0^t \frac{|a'(s)| r |\eta|^2}{a(s)(1+r)^2 |\eta|^2 + 1} \, \mathrm{d}s \le \frac{1}{r} \int_0^t \frac{|a'(s)| r^2 |\eta|^2}{a(s) r^2 |\eta|^2 + 1} \, \mathrm{d}s \le \frac{1}{r} N \log(1+r|\eta|) + C \le N \log(1+|\eta|) + C \,.$$

This completes the proof of the lemma.

#### Appendix

Given  $a(t,\xi) = \sum_{i,j}^{1,n} a_{ij}(t)\xi_i\xi_j$ , with  $a(t,\xi) \ge 0$ ,  $a_{ij}(t) = a_{ji}(t)$ ,  $a_{ij}(t) \in C^1$ , we consider the following condition (due to Kajitani [Ka]):

there exists a real function  $f(t,\xi) \in C(0,T; C^{\infty}) \cap C^1$  such that

$$\frac{|a_t'(t,\xi)|}{a(t,\xi) + (f(t,\xi))^2} \le f(t,\xi),$$
(A.1)

$$\int_0^T f(s,\xi) \,\mathrm{d}s \le C \log(\langle \xi \rangle + 1) \,, \tag{A.2}$$

$$\left| f^{(\alpha)}(t,\xi) \right| \le Cf(t,\xi)\langle\xi\rangle^{-|\alpha|}, \qquad (A.3)$$
$$\left| f'_t(t,\xi) \right| \le C(f(t,\xi))^2.$$

We exhibit a function  $a(t,\xi)$ , analytic in t, which doesn't satisfy Kajitani condition.

Let  $a(t,\xi) = (\xi_1 - t\xi_2)^2$ ,  $0 \le t \le 1$ . Suppose that  $\xi_2 > 0$ ,  $f \ge 1$  (we add 1 to f if necessary). Define  $\xi^{(0)} = (1 + t\xi_2, \xi_2)$ ,  $\xi^{(1)} = (\xi_2/2, \xi_2)$ , then (1) implies that

$$2\xi_2 \le (f+f^3)(t,\xi^{(0)}) \le 2f^3(t,\xi^{(0)}), \quad f(t,\xi^{(0)}) \ge \sqrt[3]{\xi_2}$$

and (2) gives

meas 
$$\left\{ t : f(t, \xi^{(1)}) > \frac{1}{m} \sqrt[3]{\xi_2} \right\} \frac{1}{m} \sqrt[3]{\xi_2} \le C \left( \log \langle \xi^{(1)} \rangle + 1 \right).$$

Hence

meas 
$$\left\{t: f(t,\xi^{(1)}) > \frac{1}{m} \sqrt[3]{\xi_2}\right\} \to 0 \text{ as } \xi_2 \to +\infty.$$

In particular for some  $\xi_2$  big enough there exists  $t \in [\frac{1}{2}, 1]$  such that  $f(t, \xi^{(1)}) \leq (1/m) \sqrt[3]{\xi_2}, f(t, \xi^{(0)}) \geq \sqrt[3]{\xi_2}$ . Hence

$$\log f(t,\xi^{(0)}) - \log f(t,\xi^{(1)}) =$$

$$= \frac{\frac{\partial f}{\partial \xi_1} \left( t, \xi^{(1)} + \theta(\xi^{(0)} - \xi^{(1)}) \right)}{f\left( t, \xi^{(1)} + \theta(\xi^{(0)} - \xi^{(1)}) \right)} \left( 1 + t\xi_2 - \frac{1}{2}\xi_2 \right)$$

with  $0 < \theta < 1$ . Since  $1 + t\xi_2 - \frac{1}{2}\xi_2 \leq \sqrt{2(1+\xi_2^2)}$ , we get the following inequality in the point  $(t, \xi^{(1)} + \theta(\xi^{(0)} - \xi^{(1)}))$ :

$$\sqrt{2}\langle \xi \rangle \frac{\partial f}{\partial \xi_1} / f \ge \log m$$
.

It follows that (3) is not satisfied for  $\alpha = e_1$ .
